WE FUND RESEARCH FOR INNOVATIVE, NON-TOXIC THERAPIES TO TREAT A CHILD'S TUMOR SO THAT THEY CAN CONTINUE TO LEAD HEALTHY, FULL AND PRODUCTIVE LIVES. TODAY A CHILD WITH A BRAIN TUMOR WILL LIKELY NOT SURVIVE TO SEE MIDDLE SCHOOL. 50% OF CHILDREN WITH A BRAIN TUMOR DO NOT SURVIVE.
